

## **PROJECT SAHAJOGA**

Strengthening Women Vegetable Growers' Cooperative in three districts of Odisha in India



Meeting of Kalyani Co-operative, Rengsapalli, Kalahandi

Vegetable cultivation as a subsector has huge potential for enhancing household level income of small and marginal farmers. In view of this, Madhyam Foundation has been implementing this project since October 2009 with the support of AWO International, Germany. Over the years, Madhyam Foundation in collaboration with 8 partner NGOs (Darbar Sahitya Sansad) Khurdha, Parivartan, Lok Yojana, Mahashakti Foundation, DAPTA(Kalahandi), PUSPAC, SOMKS, Parivarttan(Malkangiri) has successfully demonstrated a model to intervene at different stages to maximize production and productivity for women vegetable growers having landholding of less than two acre.

In sync with AWO International's new strategy for the region, the current phase of the project (2017-19) has additional focus on enhancing social protection of women vegetable growers and minimizing gender based discrimination in their families/community apart from consolidating the intervention undertaken during previous phases.



## Following intervention were made at different stages

#### **Pre-Production stage**

Enrollment of new growers, soil testing, soil treatment, household level crop plan, seed bank and handholding support by community service providers.

## **Production Stage**

Seed treatment, mobilization of working capital loan and Govt. scheme, promotion of organic manures and pesticides, pest control and on-site guidance by experts, Support for 120 no of water lifting pumps & delivery pipes and 12 bore wells to the cooperatives to address critical irrigation requirement.

#### **Post-Production Stage**

Aggregation of vegetables, Sorting, Grading, washing, Zero Energy cold storage for interim storage and Institutional linkage for Marketing.

## **Institution Building**

Promotion and registration of vegetable growers' cooperative, infrastructure support, Revolving fund support, Development of five year business plan, training and exposure visits.

## Achievements (As on March, 2018)

- 2117 acres of land belonging to 3048 farmers
- could be brought under vegetable cultivation
- Each vegetable farmer earned Rs 40,000/- to 45,000/- out of vegetable cultivation during the year.
- 16 vegetable growers Co-operative with 8801 members have been functioning efficiently.
- An amount of Rupees 9,206,620/- was leveraged under different Govt. schemes for agricultural inputs like seed kits, poly house, delivery pipes, bore wells, water lifting pumps, vermin compost pit,
  - sprayer, Dugwell, goat shed, Cow shed, 'Mo Pokhari' etc during this year.
- 594 landless women farmers had undertaken vegetable cultivation taking 301 acre land on lease.
- 2676 households from the project area were linked to various social security schemes of the government such as old age pension (192households), Mahatma Gandhi National Rural Employment Guarantee Act(1662), Rastriya Swasthya Bima Yojana(348), Public

- Distribution System(6823), Janani Surakhya yojana(750), Pradhan Mantri janadhan Yojana (356), Biju Krushak Kalyan Yojana(501) etc.
- 5611 women vegetable growers actively participated in various local decision making institutions such as local self government, village development committees, village education committees etc.
- 573 domestic violence cases were resolved by the members of co-operatives

# MAHILA KISAN SASHAKTIKARAN PARIYOJANA (MKSP-I)

Promoting Livelihood security among women farmers in South Odisha



In spite of the critical role played by the women in agriculture and allied activities and their rightful entitlement over factors of production as agricultural workers and cultivators, the agricultural support system in India has not been able to ensure inclusion of women force into the set-up. To improve the present status of women in agriculture, the government of India has launched MKSP as a sub component of the National Rural Livelihood Mission (NRLM). The primary objective of MKSP is to empower women in agriculture by strengthening community institutions of poor women farmers and leverage their strength to promote sustainable agriculture. Under the pattern of assistance for MKSP project, 75% is supported by NRLM and rest 25% is mobilized from the respective state government or any other donor agency.

A consortium of NGOs such as Madhyam Foundation, RCDC, Harsha Trust, OPDSC, Pragati and Chetna Organic Farmers Association (COFA), all members of South Odisha Development Initiative (SODI), have been implementing the MKSP project in 4 districts of South Odisha w.e.f. July, 2013. The main focus of the project is to ensure food security of the women farmers, enhance household level income and



promote strong vibrant community based institution of women farmers for improving their collective bargaining power. For implementing this three year project, NRLM, Govt. of India has sanctioned 75% of the project cost and rest 25% support were mobilized from Tata Trusts, Mumbai. As convener of this consortium, Madhyam Foundation is co-ordinating the project implementation with guidance and supervision of Odisha Livelihood Mission, Government of Odisha. The project was given a no-cost extension till June, 2018.

#### **Social Audit:**

As a part of the project mandate, member NGOs of SODI consortium (Madhyam Foundation, RCDC, COFA, OPDSC and Pragati) organized 11 nos of social audit of the project as on March 2018. All these meetings attended by over 2783 women farmers in each location, provided a platform where Project Director, DRDA, Chairperson of Zilla Parisad, Block Development Officer, officials from different line departments of the district and concerned Sarpanchas reviewed the progress of the project. Such social audit meetings were instrumental in demonstrating transparency of the project implementation by respective implementing NGOs of the SODI consortium.

## Quarterly review meetings of partner NGOs.

During the year, three quarterly review meetings, attended by CEOs, Project co-ordinator & Accounts executives from each partner NGOs were organized at Bhubaneswar on 5th May,17, 25th October,17 and 19th March,18 respectively.

# MAHILA KISAN SASHAKTIKARAN PARIYOJANA (MKSP-II)

Empowering women vegetable growers in Khurda, Kalahandi & Malkangiri district of Odisha



Madhyam Foundation, in collaboration with nine partner NGOs has been implementing the MKSP project in 3 districts (Khurdha, Kalahandi and Malkangiri) of Odisha since July, 2013. The main focus of the project is to ensure food security of the women farmers, enhance household level income and promote strong vibrant community based institutions of women farmers for improving their collective bargaining power. For implementing this three year project, NRLM, Govt. of India has sanctioned 75% of the project cost and rest 25% support has been mobilized from Odisha Livelihood Mission, Government of Odisha. Madhyam Foundation is co-ordinating the project implementation in collaboration with 9 NGOs under the guidance and supervision of Odisha Livelihood Mission, Government of Odisha. The project has been given no-cost extension till March, 2019.

## **PROJECT SABUJA**

Enhancing Livelihood Security of tribal households and labour migrants through innovative agricultural practices



Madhyam Foundation, supported by AWO International, Germany, successfully implemented a three year project (1st, Jan, 2015—31st, Dec, 2017) in Kandhamal district of Odisha to enhance livelihood security of tribal households and labour migrants through innovative agricultural practices. The project was being implemented in 35 villages of 5 grampanchayats in G. Udayagiri block of Kandhamal district among 3,000 small and marginal farmer households

## Major activities planned under the project:

- Profiling of all 3,000 target households and a base line survey
- Promotion of paddy cultivation through SRI method, cultivation of vegetable, tuber crops, turmeric and kitchen garden
- Promotion and strengthening of one vegetable grower co-operative and two leaf plate co-operatives
- Setting up five Diversions based irrigation structures.
- Creating a data base of labour migrants, organizing awareness programmes for them, issuing I-cards and providing need based legal support to migrants



- Promoting awareness among community and PRI representatives on gender based discrimination and trafficking of women and girls and skill building programmes for potential victims of trafficking
- Promoting and strengthening a local cadre of Community Resource Persons.
- An Endline survey of the project.

## **Achievements of the Project:**

Profiling of all 3,000 target households and a Base Line survey were completed





- 516 farmers undertook paddy cultivation using SRI method and average production per half acre of land was 8 to 9 quintals. 1608 farmers undertook vegetable cultivation and each farmer got an income of Rs 30,000 to Rs 35,000 per half acre of cultivation. All 2162 households cultivated tuber crops in backyard and field bunds in 10 decimal of land and each household got 120 kg of yam and
  - 20 kg of tapioca. 2245 households raised papaya, drumstick and sem in their kitchen garden to supplement nutritional requirement of households
- Two new vegetable growers co-operative were set up at Raikala & Dugudipari village and one more new leaf plate co-operative was promoted and got registration at Dungi village in addition to the existing leaf plate co-operative at Raipalli village. The two leaf plate co-operative sold 1,99,250 leaf plates and earned Rs 2,11,800/during the year.

- Five Diversion based irrigation structures were set up at Mundakanga, Kalanaju, Redhasingh, Kashirkhol, Raipalli villages. 110 acres of land could be irrigated in those villages and each household have earned Rs. 30,000 to Rs. 35,000 out of vegetable cultivation. Availability of water at backward through DBI reduced the drudgery of women folk in the villages who used to travel long distance for fetching water for consumption. The structures were visited by no. of Govt. officials and received wide publicity in print media.
- 512 farmers have adopted new package of practices in turmeric cultivation like line swing, planting seed in raised bed, mulching, intercropping. Each farmer got an average income of Rs. 20,000 to Rs. 25,000 from half acre of land.
- An unique Identity card, signed by CEO of Madhyam and Sarpanch of the respective Panchayat was issued to 712 migrants. 35 Vigilance committee were set up to address the issues of alcoholism and domestic violence

within the community. 35 Peer groups were set up and the members were oriented about gender and trafficking issues. 5 Skill building trainings were conducted on tailoring, bag making and candle making to enhance employability of girls.

Awareness programmes through walling, street play, Jana Sampark Sibir, Rally, IEC materials and training programmes were undertaken on gender based discrimination, social issues and trafficking for SHG members, male members, PRI representatives and Project staff.

- Madhyam Foundation leveraged various schemes from Odisha Livelihood Mission, ITDA & Agriculture Department amounting Rs. 34,96,000 to supplement the project initiatives.
- An End line survey was conducted through an external consultant to access the impact of this three year project. The findings of the survey were quite encouraging.

## **PROJECT SALILA**

## **Promoting Diversion Based Irrigation**



Construction of Riser Aseemly for Household water supply

Diversion based irrigation (DBI) diverts a portion of water from natural streams located on the hill top to villages, in the downhill through underground pipes for irrigating crops and meeting household consumption needs. This technology does not need any form of energy to function as it is based on gravity flow. Apart from crop stabilization during khariff season, such irrigation is more than adequate for vegetable cultivation during rabi and summer season. Availability of water at backyard of the house reduces drudgery of women folk who otherwise have to travel quite a distance for fetching water for household consumption.

Madhyam Foundation has already set up eleven DBI structures in Ranpur block of Nayagarh district benefitting 267 households. The DBI structures set up with the support of Tata Trusts (9 structures) & Australian High Commission (2 structures) in 11 villages (Jaripada, Sanatulubi, Tikroipada,



Routraypur, Kantajhiri, Bandhamunda, Kusapalla, Bandhapalla, Bramhankumbhi, Hatibadi & Sirikuti) of Ranpur block in Nayagarh district have been providing irrigation facilities to 350 acres of land.

Madhyam Foundation was sanctioned another project by Tata Trusts for a period of 3 years (Dec,2015 – Nov,2018) to set up 15 new DBI structures in 15 new villages in Ranpur block of Nayagarh district The new project, will benefit 352 HHs providing round the year irrigation facilities to 507.5 acres of land. All the farmers of 619 HH in 26 DBI villages (11 old & 15 new proposed villages) will form a producer company as a measure of sustainability.

## The project has following new elements in comparison to last two phases of DBI project.

- Increase in productivity, cropping are & cropping intensity through systematic planning.
- Introducing crop planning, (season-wise, water requirement specific & market driven) package of practices.
- Demonstrating two remunerative models on 0.5 acre land.
- Increase in HH level income to Rs. 70,000 by 3rd year & Rs. 90,000 by 4th/5th year.
- Setting up drinking water filtration plant in 50% DBI villages.
- Strong emphasis on leveraging support from community, govt. depts. & other potential donors.

- Collectivizing the farmers into a producer company for facilitating market & other linkages.
- Motivating the farmers to pay user fee for DBI & drinking water facilities so that substantial amount of the infrastructure cost could come back to build a fund base for the farmers company.

## Progress so far (As on March 2018)

All the 15 DBI structures were completed, as planned in 15 villages of Ranpur block. Total 614 acres could be irrigated by these structures benefitting 362 households, who were able to start vegetable cultivation in their homestead & backyard, apart from providing critical irrigation to Kharif crops.

- Twelve 0.5 acre model plot were completed to demonstrate as to how production & income could be maximized due to crop diversification & systematic planning.
- 2 12 community Nurseries were set up and 12 Model kitchen garden were also developed for demonstration.
- Training were imparted to the farmers of all DBI villages on formation & management of water user groups, paddy cultivation using SRI method, preparation & application of organic manure, crop plan etc.
- Total amount of Rs. 70,09,247 were mobilized from community by way of voluntary labour contribution towards approach road clearance, construction of intake structures, trench digging, pipe laying etc.
- An amount of Rs. 10,033,412 was mobilized from Horticulture Dept. of Odisha Govt. for plantation of cashew & mango trees, onion seeds, Water melon seeds, improved variety of vegetable seeds, banana plantation, vermi compost pits etc. as convergence.
- Process for registering a Farmer Producer Company in the project area was completed during the year and registration certificate is expected during May/June, 2018.

## **PROJECT SAMARTHA**

Placement linked Skill Building project for Rural Youth (DDU-GKY)



Deen Dayal Gramin Kaushal Yojana (DDU-GKY), Funded by Govt. of India through ORMAS, Department of Panchayatiraj, Govt. of Odisha aims to create sustainable impact on rural poverty by skilling rural youth and linking them with regular wage employment. After successful completion of the first DDUOGKY project, Madhyam was sanctioned a Second project during January, 2017 to provide skill training to 510 youth in trades such as Operation of Industrial Sewing machine, Repair of window & split AC & Refrigerators, BPO and Agriculture extension work. During this year, Madhyam completed training for 505 youth, out of which 349 were provided placement in different towns of Odisha, Bengaluru, Ahmedabad & Pune. Madhyam keeps in touch with all the placed youth through regular tracking.





## **PROJECT SAMBHABANA**

(Enhanced Livelihood Security for Marginalized tribal households and labour migrants through innovative agriculture in Malkangiri district of Odisha)

Madhyam Foundation, supported by AWO International of Germany is implementing a five year project (Jan,2017 – Dec,2021) in 48 villages of Khairput block in Malkangiri district of Odisha. The project aims to increase household level food security, enhance household level income, reduce vulnerability of distressed migrants and minimize gender based discrimination among 3,000 targeted households.

## Major activities planned under the project

- Profiling of all 3,000 target households
- Promotion of paddy cultivation through SRI method, cultivation of vegetable, millet, pulses, tuber crops and backyard poultry for landless families



- Creating a data base of labour migrants, organizing awareness programmes ( Jana Sampark Sibir, walling, IEC materials), issuing Icards and providing need based legal support to migrants
- Promoting awareness among community and PRI representatives on gender based discrimination.
- Promoting and strengthening a local cadre of Community Resource Persons.
- Strengthening of women vegetable growers cooperative

## Achievements of the Project (As on March, 2018):

- Profiling of all 3,000 targeted households completed.
- Subsequent to 30 Field level trainings on SRI, 619 farmers undertook paddy cultivation using SRI method in 408 acres of land. Average yield per acre was 16 quintals.
- 13 trainings on improved practices of Pulses cultivation were provided to 368 farmers. As a result, 545 farmers undertook pulses cultivation in 272.5 acre of land.

- 7 training were organized for 183 farmers on improved practices of Millet cultivation. Subsequent to these trainings, 445 farmers undertook Millet cultivation in 439 acres using SMI method. A crop cutting exercise was undertaken in the presence of Asst. Agriculture Officer of the block and PRI members. Average yield per acre was 8 quintal and highest yield per acre was 13 quintal per acre in Kandhattalguda village.
- 875 farmers undertook vegetable cultivation by following crop plan & use of organic manure & pesticides. Each vegetable growers earned an income of Rs. 35,000 Rs. 40,000. 3vegetable collection centers were set up to promote collective marketing.
- 50 landless farmers were supported 150 chicken for backyard poultry. Trainings were given on disease management.



- 393 farmers were supported Yam & Tapioca seeds to plant it on 73.3 acres of homestead land. Each farmers harvested 40-50kg for their household consumption.
- A database on Migration was created through household survey. Walling, public awareness camps were organized to spread awareness about different facets of migration. 808 migrants accessed different Social Security Schemes of

- the Govt. 200 I-cards were issued to migrants & 4 Legal Clinics were organized to sort out the issues faced by the migrants.
- 18 awareness programmes were conducted for male members of the targeted households & members of SHGs to sensitize them different facets of gender discrimination.
- 34 cases of domestic violence were solved by the Co-operative.

## **PROJECT SASHYA**

Special Programme for Promotion of Millets in Tribal areas of Odisha



Government of Odisha, under its Department of Agriculture and Farmers empowerment, launched a special programme for promotion of millets in tribal areas of Odisha during 2017. This programme aims to improve millet based cropping system in nearly 30,000 acre @ 1,000 acre per block covering 30 blocks with significant tribal population in seven districts (Kalahandi, Koraput, Kandhamal, Malkangiri, Rayagada, Gajapati and Nuapada) of Odisha. In addition to increasing productivity through various agronomic measures, the programme also intends to promote processing and business enterprises stakeholders of the programme:

- Directorate of Agriculture and Food production, Govt. of Odisha is the nodal agency for monitoring & implementation of the programme.
- Programme Secretariat is anchored by WASSAN and Research Secretariat is anchored by Nabakrushna Choudhury Centre for Development studies (NCDS), Bhubaneswar.
- Agriculture technology & Management Agency (ATMA) is the Programme Administration unit of all the district level.

An NGO, active in the block is chosen as the Facilitating agency and a Community Based Organization (CBO), identified/ promoted by the facilitating agency is responsible for project implementation.

Madhyam Foundation was selected as a Facilitating agency for Khairput block in Malkangiri district during June,2017. Narisakti Panipariba Utpadankari Mahila Samabaya Samiti Ltd, promoted by Madhyam Foundation was chosen for project implementation under the supervision & the guide dance of Madhyam.

## Progress as on 31st March, 2018:

- A baseline survey was undertaken to identify the Millet farmers and the existing cropping practices.
- 8 capacity building training were organized for 166 Millet farmers on areas of Systematic Millet Intensification (SMI) method, preparation & application of organic manure, seed preservation and value addition for millet products.
- During the Kharif season of 2017-18, 303 farmers cultivated millet on 3.7 acres of land by following SMI and line transplanting method. An amount of Rs. 4,83,000 was mobilized from ATMA, Malkangiri for these 303 farmers as convergence.
- Against the average production of 6 to 7 quintals per acre, the farmers got 13.52 quintal per acre (highest) by following SMI method and farmers adopting Line transplanting method got 12.79 quintal per acre. The farmers were quite happy for such increased yield per acre which they had never expected before.
- Food & Nutrition Commissioner, Govt. of Odisha, District Collector, Malkangiri & number of senior Govt. Officials visited Muduliguda village of Rasabeda Gram panchayat in 4 Khairput block on 26th July,2017 and interacted with our millet farmers.

## Project on "Small Farmers, Large Fields" (October, 2016 – October, 2017)

Madhyam Foundation implemented this Pilot Project in Taraboisasan and Khanijpur village of Nimapada block in Puri district of Odisha. The project implemented in 212 acres of land belonging to 112 farmers, demonstrated Scale efficiency by developing a model of community farming (paddy cultivation) which pools small & marginal farmers together, enabling them with efficient, cost-effective input use, technical knowledge and infrastructure facilities. The pilot project helped the small farmers overcome constraints in accessing inputs, formal credit, and extension of marketing.

## Crop Insurance Survey (2017-2018)

Madhyam Foundation, with funding support from IRRI and Department of Agriculture and Farmer empowerment, Govt. of Odisha, launched a crop insurance Survey in 15 districts of Odisha. The survey aims to analyze the current status of crop insurance and Social acceptance of Insurance product by farmers. The survey is ongoing and is expected to be completed by August, 2018.




