
Proactive Public Disclosure policy

In static information the following information's are covered as per NRLM guide line

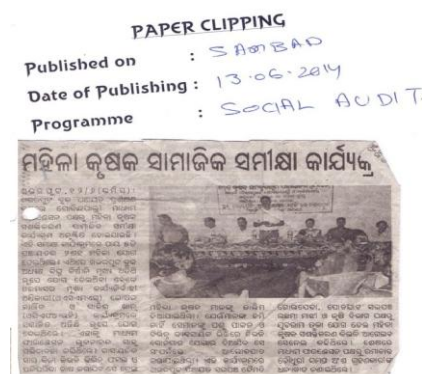
In Dynamic Information the following information are covered as per NRLM Guideline and data has been updated once in a month.



Panchayat level: At Panchayat level a copy of key task and intervention point to be covered in the project including budget has been given to the Panchayat office. The PRI members (Sarapanch, Ward members, BLCC& DLCC members) of intervention Panchayats were oriented on the project at Block level orientation training by the project team. A leaf let on Project were distributed on project activities to the PORI members. Each year social audits were planned to be organized at Panchayat level .

At Block Level:

Hoardings are planned to be made in intervention blocks to disseminate about the implementation of Mahilakishan SashaktiKaran Pariyojana. Block Development Officer and all the block level Govt Officials (Agriculture, Horticulture, ATMA, BPL OLM) were appraised by



the PIA about the implementation of The project. They are also regularly invited by the PIA To attend the events and visit the field

District level

The project proposal, training calendar, plan of action, Target Vs achievements has regularly shared by Madhyam Foundation. Yearly District level interface face meetings with all line departments planned by Madhyam Foundation

At PIA level

Wall paintings has been made in the PIA project office indicating intervention village, no of Mahilakishan covered, No of CRP No of PRP, complain redressal officer name and phone number & Key tasks of the project etc .

- PRP & Programme Managers at Panchayat & block level are assigned for redressed of grievance as an internal procedure of redressal of grievances. As result the grievances of Mahilakishan s could addressed within maximum 4 to 5 hours

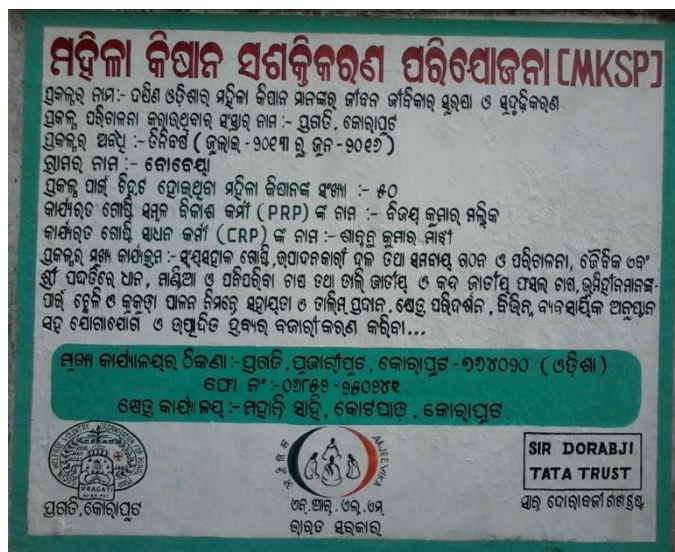


Figure 8 Public disclosure at Koraput district
